New Jersey Residents: Did you know there is an Income Tax Exemption for Veterans?

For the 2017 tax year, N J Residents are eligible for a \$3,000 exemption on your Income Tax return if you are a military veteran who was honorably discharged or released under honorable circumstances from active duty in the Armed Forces of the United States on or any time before the last day of the tax year. Your spouse (or civil union partner) is also eligible for an exemption if he/she is a veteran who was honorably discharged or released under honorable circumstances and you are filing a joint return. This exemption is in addition to any other exemptions you are entitled to claim and is available on both the resident and nonresident returns. You cannot claim this exemption for a domestic partner or for your dependents. For more information please visit <http://www.state.nj.us/treasury/taxation/newexemptionveterans.shtml>



Having Problems Accessing myPay or do not have access to myPay?

If the member cannot access their myPay account, here is how they can get access:

How to Request a Temporary Password

- Go to <https://mypay.dfas.mil>
 - Click “Forgot or Need a Password?”
 - Enter their Social Security Number and click the “Yes” button on the bottom right.
 - Choose “mail to my address of record with Military Retired” and click “Send me a Password.”
- Or, if they have a valid email address in myPay, they can have it emailed. The member should receive their temporary password in 10 business days by mail or two hours by email. If they don’t, they need to update their mailing address.

How to Create a Permanent Password and Login ID

- Once they receive their temporary password, they should return to myPay. If they have never accessed myPay, click “Create an Account.” If they are reactivating their account, please see “How to Reactivate an Account” below.
- Enter their Social Security Number and temporary password and click “Accept/Submit.”
- Create a permanent Login ID and password.
- Select eight security questions that they can answer later if they need to reset their password. Click “Submit Questions.”
- Answer each question and click “Submit Answers.”
- If they do not have an email address on record, add one.
- Select “Main” in the upper right corner to use myPay.

How to Reactivate an Account

- Once they receive their temporary password, return to myPay (<https://mypay.dfas.mil>).
- Log into myPay using their Login ID and their new temporary password.
- Create a new permanent password.
- Select “Main” in the upper right corner.

BEST WAYS TO GET OR REPLACE A 1099R

Military retirees and annuitants receive a 1099R tax statement either electronically via myPay or as a paper copy in their mail each year. If the document gets misplaced or one is needed from a previous year, retirees can request copies of their 1099R in several different ways.

The fastest and most secure way to obtain a copy of the 1099R is myPay. Members can login to the myPay website and print their 1099R when they need it.

The interactive voice response system (IVRS) is the most convenient and fastest method for members that don’t have myPay accounts. If the mailing address we have on file is current, the member can get a copy of their 1099R by using the telephone self-service option. Telephone self-service requests are logged instantly and they are sent to to the member’s current address of record within 7-10 business days. To use the telephone

self-service call 1-800-321-1080, and follow the prompts.

Members with unique situations can speak directly to a customer care representative by also calling 1-800-321-1080.
