

# Annual Water Consumer Confidence Report

Dix Drinking Water System on Joint Base McGuire-Dix-Lakehurst (JB MDL)

Public Water System ID No. 0325001

Monitoring Period: January 1, 2015 – December 31, 2015

## Is my water safe?

Yes. Members of the 87th Air Base Wing, Medical, Civil Engineering Support groups and Pride Industries vigilantly safeguard water supplies and once again we are proud to report that our system currently is in full compliance with primary water quality standards. This report is being distributed to you, the consumer, to provide you with information to allow you to make personal health-based decisions regarding drinking water consumption. The report will provide you with sampling data for the water system and discuss the health concerns for each contaminant detected in the system. The report will provide you with definitions so you understand the material presented.

#### Where does my water come from?

The water for the Dix system is pumped from the Rancocas Creek and the Potomac-Raritan-Magothy (PRM) Aquifer System. Water from the Rancocas Creek is classified by the State of New Jersey, Bureau of Safe Drinking Water, as Fresh Waters, Category Two (FW-2) Non-Trout. Dix is currently permitted to divert groundwater from groundwater wells located within the Dix cantonment area. The US Geological Survey Dept operates a stream gauging station at the point of entry from Rancocas Creek to monitor stream flows and water quality parameters. This real-time monitoring ensures any potential health risks from low stream flow and pollution sources are prevented by informing the water plant operators of flow conditions.

The Dix Water Filtration Plant is a conventional rapid sand filter plant consisting of the following unit operations: rapid mixing, flocculation (a process where solids in water aggregate through chemical action so they can be separated from water), sedimentation (solids settling by gravity), and multimedia filtration. The water is treated at the Water Filtration Plant with aluminum sulfate for flocculation and clarification. The main source of raw water for the Water Filtration Plant is the Rancocas Creek. If a shutdown is required for filtration plant maintenance or the stream flow falls below the specified limit, the facility production can be supplemented with groundwater from wells to maintain an adequate water supply.

## Source Water Assessments

The NJDEP has prepared Source Water Assessment Reports and Summaries for all public water systems. #### Source Water Assessment Summary

The results of the source water assessment performed on our five water sources (2) active groundwater wells, (2) inactive groundwater wells, and one (1) surface water source are presented in the following table. The table illustrates the susceptibility ratings for the seven contaminant categories and radon for each well in the system. The table provides the rating for each well: high, medium, and low for each contaminant category. The Dix system does not have any sources that are classified as ground water under the direct influence of surface water, and it does not purchase water from other public water systems. The eight contaminant categories are defined in Table 1.

**Pathogens**: Disease causing organisms such as bacteria and viruses. Common sources are animal and human fecal wastes.

**Nutrients**: Compounds, minerals and elements that aid growth, that are both naturally occurring and manmade. Examples include nitrogen and phosphorous.

**VOC's**: Man-made chemicals used as solvents, degreasers and gasoline components. Examples include benzene, methyl tertiary butyl ether (MTBE) and vinyl chloride.

**Pesticides**: Man-made chemicals used to control pests, weeds and fungus. Common sources include land application and manufacturing of pesticides. Examples include herbicides such as atrazine and insecticides such as chlordane.

**Inorganics**: Mineral based compounds that are both naturally occurring and man-made. Examples include arsenic, asbestos, copper, lead and nitrate.

**Radionuclides**: Radioactive substances are both naturally occurring and man-made. Examples include radium and uranium.

Radon: Colorless, odorless, cancer causing gas that occurs naturally in the environment.

**DBPs**: A common source is naturally occurring organic matter in surface water. Disinfection byproducts are formed when the disinfectant (usually chlorine) used to kill pathogens reacts with dissolved organic material (for example leaves) present in surface water.

If a system is rated highly susceptible for a contamination category, it does not mean a customer is or will be consuming contaminated water. The rating reflects the potential for contamination of source water, not the existence of contamination. Public water systems are required to monitor for regulated contaminants and to install treatment if any are detected at frequencies and concentrations above allowable levels.

NJDEP found the following potential contaminant sources within the source water assessment areas for our sources. All potential contaminant sources are on the base.

- 1. Solid and hazardous waste handling and transfer facilities.
- 2. Closed solid waste landfill.
- 3. Septic tanks.
- 4. Urban, commercial and industrial land use.
- 5. Distance of the wells to wetlands.
- 6. The Golf Course.
- 7. Population density.
- 8. Density of known contaminated sites, and NJDEP permitted surface water discharges.

# **Source Water Protection Tips**

Protection of drinking water is everyone's responsibility. You can help protect your community's drinking water source in several ways:

- Eliminate excess use of lawn and garden fertilizers and pesticides they contain hazardous chemicals that can reach your drinking water source
- Pick up after your pets
- If you have your own septic system, properly maintain your system to reduce leaching to water sources or consider connecting to a public water system
- Dispose of chemicals properly; take used motor oil to a recycling center
- Volunteer in your community. Find a watershed or wellhead protection organization in your community and volunteer to help. If there are no active groups consider starting one. Use EPA's Adopt Your Watershed to locate groups in your community, or visit the Watershed Information Network's How to Start a Watershed Team
- Organize a storm drain stenciling project with your local government or water supplier. Stencil a message next to the street drain reminding people "Dump No Waste Drains to River" or "Protect Your Water." Produce and distribute a flyer for households to remind residents that storm drains dump directly into your local water body.

# Sources of Drinking Water Contamination

Sources of drinking water (both tap water and bottled water) may include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Regulated substances that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses;
- Organic chemical compounds, including synthetic organic compounds (SOCs) and volatile organic compounds (VOCs), which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems;
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health. Table 2 summarizes the regulated analytes and monitoring frequencies for the wells (points of entry) and distribution system servicing the Dix area.

The NJDEP regulations allow monitoring waivers to reduce or eliminate the monitoring requirements for asbestos, radiological, VOCs, and SOCs. Our system received monitoring waivers for asbestos, radiological, and SOCs because prior samplings have demonstrated that these substances were not detected in our source water.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. # Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. JB MDL is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. JB MDL participated in Lead and Copper monitoring in 2015 and is scheduled to participate again in 2018. 90% of all sample results must be at or below the Action Level (AL).

Of the 32 samples collected in 2015 for Lead, the 90th percentile result was 1 ppb. The highest concentration detected in one single sample was 43 ppb. The AL by regulation is 15 ppb.

Of the 32 samples collected in 2015 for Copper, the 90th percentile result was 0.4 mg/L. The highest concentration detected in one single sample was 1.3 mg/L. The AL by regulation is 1.3 mg/L.

# **Unregulated Contaminant Monitoring Rule - 3**

The EPA uses the Unregulated Contaminant Monitoring (UCM) program to collect data for contaminants suspected to be present in drinking water, but that do not have health-based standards set under the Safe Drinking Water Act. Every five years the EPA reviews the list of potential contaminants and chooses up to 30 for which to monitor. In 2014 24 contaminants were chosen and JB MDL participated. Of those chosen, 4 were detected in JB MDL water. The EPA will review the results provided for the entire country and determine if regulation is needed. The contaminants detected are located in Table 3.

# Water Quality Data Tables

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of contaminants in water provided by public water systems. Table 3 below lists the drinking water monitoring results for 2014. Some of our data, though representative, may be more than one year old. To help you understand the contents of this Consumer Confidence Report, we have provided the common abbreviations, terms, and definitions in Tables 3 and 4 below.

## **Table 3- Water Monitoring Results**

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Although many more contaminants were tested, only those substances listed above were found in your water. All sources of drinking water contain some naturally occurring contaminants. At low levels, these substances are generally not harmful in our drinking water. Removing all contaminants would be extremely expensive, and in most cases, would not provide increased protection of public health. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination.
