Categories of Suspicious Behavior

Surveillance

May include note taking, photography, drawing diagrams, and using binoculars.

Elicitation

Attempts to obtain information on people, assets, procedures or security.

Tests of Security

Attempts to breach security measures or measure response times.

Acquiring Supplies

Obtaining chemicals, explosives, infected materials etc.

Suspicious Person(s)

Person(s) who do not appear to belong in a given setting perhaps exhibiting suspicious behavior.

Dry Runs

Preparatory behaviors such as practice runs or route mapping.

Deploying Assets

Placing people and supplies into a place to commit an attack e.g. abandoned car.

Anti-Terrorism

Our JB MDL community relies on your observations to report suspicious activity. Look for **unusual items or situations** such as a car parked in an unusual spot or a person asking you questions, attempting to **eliciting information** about our security measures or operations on the Joint Base. Look for people who appear to loiter in concealed areas or are seen repeatedly in the same area who may be attempting to **observe or surveil** the Joint Base.

Our Joint Base Law Enforcement Officials will investigate and determine whether the behavior is suspicious or not.

How should you report suspicious activity?

Who you saw, when you saw it, where it occurred and why it's suspicious, answers to these are the questions will help Joint Base Law Enforcement Officials.

Use the SALUTE report, to cover the basic information law enforcement will need, and any additional details regardless of how big or small. If you see something suspicious and wish to report it you can call (609) 562-6001 on the McGuire/Dix side of JB MDL or (732) 323-4000 on the Lakehurst side of JB MDL to reach the Law Enforcement desk. *If it is an emergency dial 911*.

All too often we are reminded that terrorism continues to inflict pain and suffering all over the world. Staying sharp will help mitigate potential threats and deter terrorists from accomplishing their objectives. Remember... If you see *something*, say *something*.

What to Report:

- * <u>Size</u> Number and description of person (s)
- * Activity What is suspicious
- * <u>Location</u> Location of activity.
- * <u>Unit/Uniform</u> What unit they belong to and what they are wearing.
- * <u>Time</u> Date and time you observed the activity.
- * <u>Equipment</u> Description of any equipment being used.
