## Non-Judicial Punishment

A Staff Sergeant assigned to the 18th Weather Squadron was punished under Article 15 for Wrongful Use of a Schedule II Controlled Substance. The punishment included a reduction to Senior Airman, suspended for 6 months, forfeitures of \$1,000.00 pay per month for 2 months, 15 days extra duty, and a reprimand.

A Senior Airman assigned to the 305th Aircraft Maintenance Squadron was punished under Article 15 for Dereliction of Duty: Tech Order noncompliance. The punishment included forfeitures of \$649.00 pay per month for 2 months and a reprimand.

A Senior Airman assigned to the 305th Aircraft Maintenance Squadron was punished under Article 15 for Dereliction of Duty and False Official Statements. The punishment included a reduction to Airman First Class, suspended for 6 months, forfeitures of \$513.00 pay per month for 2 months, and a reprimand.

An Airman First Class assigned to the 32d Air Refueling Squadron was punished under Article 15 for Failure to Go and False Official Statement. The punishment included a reduction to Airman, suspended for 6 months, forfeitures of \$125.00 pay per month for 2 months, and a reprimand.

An Airman First Class assigned to the 605th Aircraft Maintenance Squadron was punished under Article 15 for Wrongful Use of Marijuana. The punishment included forfeitures of \$1,026.00 pay per month for 2 months, suspended for 6 months, and a reprimand.

A Senior Airman assigned to the 6th Airlift Squadron was punished under Article 15 for Failure to Obey a Lawful Order and an Unprofessional Relationship. The punishment included a reduction to Airman First Class, forfeitures of \$1,088.00 pay per month for 2 months, suspended for 6 months, and a reprimand.

# Administrative Discharges

An Airman First Class assigned to the 305th Aircraft Maintenance Squadron was administratively discharged without Probation and Rehabilitation (P&R) for Misconduct: Drug Abuse. The Airman received an Under Honorable Conditions (General) service characterization.

An Airman First Class assigned to the 305th Aircraft Maintenance Squadron was administratively discharged without P&R for Misconduct: Minor Disciplinary Infractions. The Airman received an Under Honorable Conditions (General) service characterization.

A Senior Airman assigned to the 87th Logistics Readiness Squadron was administratively discharged without P&R for Unsatisfactory Performance: Failure to Meet Minimum Fitness Standards. The Airman received an Honorable service characterization.

An Airman First Class assigned to the 605th Aircraft Maintenance Squadron was administratively discharged without P&R for Conditions that Interfere with Military Service: Mental Disorder not Constituting a Physical Disability. The Airman received an Honorable service characterization.

An Airman assigned to the 87th Force Support Squadron was administratively discharged without P&R for Misconduct: Drug Abuse. The Airman received an Under Honorable Conditions (General) service characterization.
