A Senior Airman assigned to the 20th Air Support Operations Squadron was found guilty of MDMA use on divers occasions in a Summary Court-Martial proceeding. The approved sentence included a Reduction to Airman Basic, confinement for 15 days, forfeiture of \$1,092.00 for one month and a reprimand.

An Airman First Class assigned to the 305th Aerial Port Squadron was demoted to Airman for Fitness Failure.

Non-Judicial Punishment

A Staff Sergeant assigned to the 87th Civil Engineer Squadron was punished under Article 15 for Going from his Place of Duty. The punishment included a reduction to Senior Airman, forfeiture of \$1298.00 pay per month for 2 months suspended for 4 months, and a reprimand.

An Airman First Class assigned to the 87th Logistics Readiness Squadron was punished under Article 15 for Possession, Use, and Wrongful Introduction of Marijuana on the Installation. The punishment included a reduction to Airman Basic and a reprimand.

An Airman First Class assigned to the 87th Logistics Readiness Squadron was punished under Article 15 for Possession of Marijuana and Introduction of Marijuana on the Installation. The punishment included a reduction to Airman Basic and a reprimand.

An Airman First Class assigned to the 787th Civil Engineer Squadron was punished under Article 15 for Drunken Driving. The punishment included a reduction to Airman Basic, with reduction below Airman suspended for 6 months, forfeiture of \$428.00 pay for one month suspended for 6 months, and a reprimand.

An Airman First Class assigned to the 605th Aircraft Maintenance Squadron was punished under Article 15 for Abusive Sexual Contact, Drunken Driving, and Indecent viewing, recording, or broadcasting the private area of another person. The punishment included Reduction to the grade of Airman and a reprimand.

A Technical Sergeant assigned to the 87th Security Forces Squadron was punished under Article 15 for Willful Dereliction of Duty. The punishment included a reduction to Staff Sergeant and a reprimand.

An Airman First Class assigned to the 87th Communications Squadron was punished under Article 15 for Failure to Go. The punishment included a reduction to Airman suspended for 6 months, forfeiture of \$459.00 and a reprimand.

An Airman First Class assigned to the 87th Civil Engineer Squadron was punished under Article 15 for Wrongful Use of Marijuana. The punishment included a reduction to Airman and a reprimand.

An Airman First Class assigned to the 305th Maintenance Squadron was punished under Article 15 for being Drunk on Duty. The punishment included a reduction to Airman suspended for six months, 14 days extra duty, and a reprimand.

A Second Lieutenant assigned to the 87th Aerospace Medicine Squadron was punished under Article 15 for Drunken Driving. The punishment included forfeiture of \$1250.00 pay for 2 months and a reprimand.

An Airman First Class assigned to the Aerial Port Squadron was punished under Article 15 for Abusive Sexual Contact. The punishment included a reduction to Airman Basic, with reduction below Airman suspended for 6 months and a reprimand.

A Senior Airman assigned to the 321st Contingency Response Squadron was punished under Article 15 for Assault Consummated by a Battery. The punishment included reduction to Airman First Class, forfeiture of \$1088.00 for 2 months, with forfeitures in excess of \$1088.00 for 1 month suspended for 6 months.

An Airman Basic assigned to the 305th Aerial Port Squadron was punished under Article 15 for Wrongful Use of a Marijuana. The punishment included a forfeiture of \$819.00 pay for 1 month suspended for 6 months, 60 days restriction and a reprimand.
