Administrative Demotions

A Senior Airman assigned to the 305th Maintenance Squadron was demoted to Airman First Class for Failure to Fulfill Airman Responsibilities.

An Airman First Class assigned to the 305th Aerial Port Squadron was demoted to Airman for failing a third fitness assessment within a 24-month period.

A Staff Sergeant assigned to the 87th Comptroller Squadron was demoted to Senior Airman for failing a third fitness assessment within a 24-month period.

A Senior Airman assigned to the 305th Operations Support Squadron was demoted to Airman First Class for failing a third fitness assessment within a 24-month period.

Non-Judicial Punishment

An Airman First Class assigned to the 305th Maintenance Squadron was punished under Article 15 for Violation of a General Order by underage drinking. The punishment included a reduction to Airman, suspended for 6 months, forfeitures of \$896.00 pay per month for 2 months, restriction to the limits of McGuire AFB, NJ for 14 days, 14 days extra duty, and a reprimand.

A Senior Airman assigned to the 87th Security Forces Squadron was punished under Article 15 for sleeping while being posted as a sentinel. The punishment included a reduction to Airman First Class, forfeitures of \$500.00 pay per month for 2 months, suspended for 6 months, and a reprimand.

A Senior Airman assigned to the 87th Force Support Squadron was punished under Article 15 for Wrongful Use of Marijuana. The punishment included a reduction to Airman, forfeitures of \$896.00 pay per month for 2 months, suspended for six months, and a reprimand.

A Senior Airman assigned to the 305th Aircraft Maintenance Squadron was punished under Article 15 for Wrongful Use of Marijuana. The punishment included a reduction to Airman First Class and a reprimand.

Administrative Discharges

An Airman Basic assigned to the 2nd Air Refueling Squadron was administratively discharged without Probation and Rehabilitation (P&R) for Misconduct: Sexual Assault. The Airman received an Under Honorable Conditions (General) service characterization.

An Airman Basic assigned to the 305th Aerial Port Squadron was administratively discharged without Probation and Rehabilitation (P&R) for Misconduct: Drug Abuse. The Airman received an Under Honorable Conditions (General) service characterization.

An Airman Basic assigned to the 305th Aircraft Maintenance Squadron was administratively discharged without Probation and Rehabilitation (P&R) for Misconduct: Drug Abuse. The Airman received an Under Honorable Conditions (General) service characterization.

An Airman assigned to the 87th Communications Squadron was administratively discharged without P&R for Commission of a Serious Offense: Larceny. The Airman received an Under Honorable Conditions (General) service characterization.

An Airman assigned to the 87th Logistics Readiness Squadron was administratively discharged without P&R for Conditions that Interfere with Military Service: Personality Disorder or Mental Disorder not Constituting a Physical Disability. The Airman received an Honorable service characterization.
