## Administrative Demotions

An Airman First Class assigned to the 305th Aerial Port Squadron was demoted to Airman for Fitness Failure.

An Airman First Class assigned to the 87th Force Support Squadron was demoted to Airman for Fitness Failure.

An Airman First Class assigned to the 87th Air Base Wing was demoted to Airman for Fitness Failure.

## Non-Judicial Punishment

A Senior Airman assigned to the 621st Contingency Response Support Squadron was punished under Article 15 for Assault Consummated by a Battery, Dereliction of Duty, Disobeying a Lawful Command, and an Unprofessional Relationship. The punishment included forfeitures of \$1,088.00 pay for 2 months and a reprimand.

A Staff Sergeant assigned to the 621st Contingency Response Support Squadron was punished under Article 15 for Wrongful Use of Marijuana. The punishment included Reduction to the grade of Senior Airman, forfeitures of \$1,298.00 pay per month for 2 months, suspended, and a reprimand.
