Upcoming Courts-Martial

A General Court-Martial has been docketed for 24 July 2018.

Completed Courts-Martial

An Airman First Class assigned to the 305th Operations Support Squadron was found guilty of Heroin use on divers occasions in a Special Court-Martial. The approved sentence included 60 days confinement and a Bad-Conduct Discharge.

A Technical Sergeant assigned to the Expeditionary Center was found guilty of two specifications of derelictions of duty for bringing a cell phone and unauthorized personnel into a controlled area at a Special Courts-Martial. The approved sentence included forfeitures of \$2,629.00 pay per month for three months, hard labor without confinement for two months, and a reprimand.

An Airman First Class assigned to the 87th Security Forces Squadron was found not guilty of sexual assault at a General Court-Martial.

Administrative Demotions

An Airman First Class assigned to the 87th Force Support Squadron was demoted to Airman for Fitness Failure.

Non-Judicial Punishment

An Airman First Class assigned to the 605th Aircraft Maintenance Squadron was punished under Article 15 for Wrongful Use of Marijuana. The punishment included a reduction to Airman, forfeiture of \$918.00 pay for two months suspended for 6 months, and a reprimand.

A Staff Sergeant assigned to the 305th Operations Support Squadron was punished under Article 15 for Failure to Obey General Order: Misuse of GTC. The punishment included forfeiture of \$1000.00 pay for one month suspended for 6 months and a reprimand.

A Staff Sergeant assigned to the 621st Contingency Response Squadron was punished under Article 15 for Willful Dereliction of Duty, Assault consummated by battery x 2, and Obstructing Justice. The punishment included restriction for 30 days suspended for 6 months, a reduction to Senior Airman, forfeiture of \$1298.00 pay for one month suspended for 6 months and a reprimand.

A Senior Airman assigned to the 321st Contingency Response Support Squadron was punished under Article 15 for Assault. The punishment included a reduction to Airman First Class, forfeiture of \$1088.00 pay per month for 2 months suspended one month of pay for 6 months, and a reprimand.

A Senior Airman assigned to the 321st Contingency Response Support Squadron was punished under Article 15 for Willful Dereliction of Duty: Misuse of GTC. The punishment included a reduction to Airman First Class, forfeiture of \$1088.00 pay per month for 2 months suspended for 6 months, and a reprimand.

An Airman First Class assigned to the 305th Aerial Port Squadron was punished under Article 15 for Abusive Sexual Contact. The punishment included a reduction to Airman Basic, with reduction below Airman suspended for 6 months, forfeiture of \$1088.00 pay per month for 2 months suspended for 6 months, and a reprimand.
