NonJudicial Punishment

An Airman First Class assigned to the 18th Weather Squadron was punished under Article 15 for being AWOL. The punishment included Reduction to the grade of Airman, forfeitures of \$428.00 per month for 2 months, suspended for a period up to six months, and a reprimand.

An Airman First Class assigned to the 305th Aircraft Maintenance Squadron was punished under Article 15 for Underage Drinking. The punishment included Reduction to the grade of Airman, suspended for a period up to six months, forfeitures of \$459.00 for 1 month, and a reprimand.

An Airman First Class assigned to the 605th Aircraft Maintenance Squadron was punished under Article 15 for Willful Dereliction of Duty and Use of a Controlled Substance. The punishment included Reduction to the grade of Airman, 21 days extra duty, forfeitures of \$918.00 per month for 2 months, suspended for a period up to six months, and a reprimand.

An Airman First Class assigned to the 605th Aircraft Maintenance Squadron was punished under Article 15 for Underage Drinking. The punishment included Reduction to the grade of Airman, forfeitures of \$918.00 for 1 month, suspended for a period up to six months, and a reprimand.

An Airman First Class assigned to the 87th Security Forces Squadron was punished under Article 15 for Damaging, Destroying, or Losing Military Property greater than \$500.00 and Reckless Driving. The punishment included reduction to the grade of Airman, suspended for a period up to six months, forfeitures of 1/2 month's pay per month for 2 months, suspended for a period up to six months, and a reprimand.

A Technical Sergeant assigned to the 87th Security Forces Squadron was punished under Article 15 for being AWOL. The punishment included Reduction to the grade of Staff Sergeant and a reprimand.
